

The documents listed below are required for UW Facilities department to meet the State's requirements for records retention and for the maintenance, repair and renovation of UW facilities. Submit these documents to the UW Facilities Engineering Services' Records team. Records only accepts digital formats (.pdf, .mp4, .dwg) unless otherwise noted.

The requirements for .pdf files are defined in the A/E agreements, attachment G for the A/E and in the Division 01 submittals specification 01 33 00. Digital .pdf records of other documents, such as specification O&Ms, reports and studies shall be submitted directly to ES Records after the PM/CM reviews them for completeness and quality. It is the project manager's responsibility to ensure that all the required documents are reviewed for completeness and quality, and that all documents indicated on the transmittal form were submitted.

AutoCAD .dwg files must be reviewed and approved by the Capital and Space Management (CSM) CAD Compliance Review Group before they are submitted.
